Discussed Agenda Item No. 5: General Liability Coverage for RRABB Land Tracts

• Currently, RRABB does not have or maintain general liability insurance that covers all of RRABB's land tracts that we lease out for recreational, agriculture and grazing tracts. It would be beneficial for the Board to discuss the possibility of obtaining such insurance to cover RRABB in case of a tenant claim. Turrentine Insurance quoted a total yearly premium of \$8,853.53 for commercial general liability coverage. RRABB would still continue to require each tenant to supply RRABB with a Certificate of General Liability Insurance with RRABB named as an additional insured.
