RESOLUTION 34-2021

WHEREAS, the Board of Commissioners of the Red River, Atchafalaya & Bayou Boeuf Levee District discussed and considered an Intergovernmental Agreement with LaDOTD concerning drainage in Rapides, Avoyelles and St. Landry Parishes; and,

WHEREAS, LaDOTD wishes to enter into an IGA with RRABB in order to conduct an H&H Study for the Courtableau-Teche-Vermilion watershed in Rapides, Avoyelles and St. Landry Parishes; and,

WHEREAS, funds for an H&H Study will come from LaDOTD and be handed down to RRABB as the local sponsoring agency; and,

WHEREAS, RRABB will administer those funds to MMLH for their engineering services on the H&H Study; and,

WHEREAS, the study is estimated to cost approximately \$250,000.00; and,
