### **RESOLUTION 52-2022**

### **DISCUSSION ITEMS**

Discussed Agenda Item No. 1: Herbicide Spraying Contract

- 8/4/2021 NaturChem representatives presented their proposed services to control Johnson grass to RRABB.
- 11/2/2021 Proposals were received by RRABB from NaturChem and Edko for two treatments of herbicide targeting Johnson grass (NatureChem \$43,500/application, Edko \$54,970/application). RRABB selected NaturChem.
- 2/2/2022 Due to timing of the 11/2/21 agreement execution with NaturChem, the weather prevented the herbicide application in 2021, therefore RRABB executed agreement with NaturChem in February with same terms as original proposal for the 2022 year.
- At the end of May, after the 1<sup>st</sup> mowing cycle was completed, NaturChem treated the levee segment. It was quickly apparent that complete coverage was not obtained leaving strips of untreated grass along the slopes of the levee. NaturChem remobilized two additional times to complete the initial application.

• A representative from NaturChem was in attendance to address any questions or concerns by the Board. The Board requested that NaturChem use a die within a test section at the start of the 2<sup>nd</sup> application to confirm the proper application coverage.

Discussed Agenda Item No. 2: Big Bend Levee Watershed Basin H&H Study Discussion

- 5/4/2021 RRABB entered into an Intergovernmental Agreement with DOTD to have an H&H study performed on the Big Bend Watershed (Pomme de Terre) in Avoyelles Parish.
- 7/5/2022 MMLH (Engineering Firm) completed the H&H Study and presented results to RRABB. In accordance with the IGA between RRABB and DOTD, the resulting H&H report was transmitted to DOTD.
- Donald Bishop has requested RRABB's assistance in completing the work to widen this existing drainage as recommended by the H&H report. He was in attendance to discuss his concerns with the Board. The Board suggested that he contact Wildlife and Fisheries for assistance with this project.

Discussed Agenda Item No. 7: City of Pineville Permit Request (Rapides Parish)

• The City of Pineville is planning to demolish two existing drainage pump stations and construct a new drainage pump station with piping extending over the levee for discharge into Huffman Creek. The project will also include the construction of a ~1.4-acre detention pond. This permit request review by both USACE and LA DOTD will require extensive coordination with the applicant. An initial telephone conference with all parties was held on July 13, 2022. Additional stipulations for long term operation and maintenance will need to be discussed to be included in this permit. The Board has tabled this permit request until RRABB Executive Director provides additional permit language to address long term operation and maintenance requirements.

Discussed Agenda Item No. 12: RRABB Drainage Policy and Related Equipment

 In September 2017, the RRABB Board of Commissioners adopted a policy manual titled, "Guidance on General Drainage Activities Performed by the RRABB Levee District" that outlined certain obligations and responsibilities that RRABB adheres to regarding drainage work within its jurisdictional boundaries. In June 2018, the RRABB Board of Commissioners revised the policy to include additional language regarding requested
